ABBREVIATED FORM OF THE ARTICLES OF FAITH

The Scriptures

- I. We believe that the holy Bible was written by men divinely inspired, that it is the truth without mixture and error; and that it is the standard by which all human conduct and creeds should be tried. II Timothy 3:15-17.

The True God

- II. We believe that there is one and only one True and Living God; that in the Unity of the Godhead there are three persons; the Father, the Son, the Holy Spirit. John 4:24; 10:30.

The Fall of Man

- III. We believe that man was created in holiness, but by voluntary transgression fell from that holy state, in consequences of which all mankind are now sinners and are under condemnation of eternal ruin. Genesis 1:27, Romans 5:11.

The Way of Salvation

- IV. We believe that the salvation of sinners is wholly of grace through the atoning death and bodily resurrection of Jesus Christ. Ephesians 2:8, Isaiah 53:4, Hebrews 7:25.
- V. We believe that through Justification the perfect righteousness of God is imputed to the believers in Christ Jesus. Acts 13:39, Romans 5:12.

The Freeness of Salvation

- VI. We believe that the blessings of salvation are made free to all by the Gospel, and that nothing prevents the salvation of the greatest sinner but his own depravity and rejection of the Gospel. Isaiah 55:1, John 3:16.

Grace in Regeneration

- VII. We believe that in order to be saved, sinners must be regenerated or born again through the work of the Holy Spirit. John 3:3, II Corinthians 6:17.

Repentance and Faith

- VIII. We believe that repentance and faith are inseparable graces, wrought in our souls by the regenerating Spirit of God, and are essential steps in salvation. Mark 1:15, Romans 10:9.

God's Purpose and Election

- IX. We believe that Election is the eternal purpose of God, according to which He graciously regenerates, sanctifies, and saves sinners; and that this is consistent with the free agency of man. Romans 8:28-31, II Peter 1:10-11.

Sanctification

- X. We believe that Sanctification is progressive process by which the believer is made partaker of God's Holiness, and that this process begins in regeneration. I Thessalonians 4:3 and that is carried on in the hearts of believers, by the presence and power of the Holy Spirit. Philippians 2:12-13.

ABBREVIATED FORM OF THE ARTICLES OF FAITH

The Perseverance of Saints

- XI. We believe that only real believers endure to the end, and that they are kept by the power of God through faith in Jesus Christ. Romans 8:32-39, II Timothy 1:12.

A Gospel Church

- XII. We believe that a Church of Christ is a congregation of baptized believers bound together in the faith and fellowship of the Gospel; and that Jesus committed the ministry of His Gospel to His churches. Acts 2:41-42.

Baptism and the Lord's Supper

- XIII. We believe that baptism is the immersion of a believer in water in the name of Father, Son, Holy Ghost, and on the authority of the New Testament and a New Testament Church. That baptism is a prerequisite to the Lord's Supper and only such as have been scripturally baptized are proper subjects for the Lord's Supper. Acts 8:36, Matthew 28:19, I Corinthians 11:26.

The Christian Sabbath

- XIV. We believe that the first day of the week is the Lord's Day and is to be kept sacred to religious purposes. Acts 20:7, Exodus 20:8.

The World to Come

- XV. We believe at the last day Christ will descend from heaven and raise the dead; that a solemn judgement and separation will take place, and that his judgement will fix forever the final state of men in Heaven or Hell. Acts 1:11, 24:15, Matthew 13:49; 25:31-46.

Church Covenant

Having been led, as we believe by the Spirit of God, to receive the Lord Jesus Christ as our Savior and, on the profession of our faith, having been baptized in the name of the Father and of the Son, and of the Holy Spirit, we do now, in the presence of God, and this assembly, most solemnly and joyfully enter into covenant with one another as one body in Christ.

We engage, therefore, by the aid of the Holy Spirit to walk together in Christian love, to strive for the advancement of this church, in knowledge, holiness and comfort, to promote its prosperity and spirituality; to sustain its worship, ordinances, discipline, and doctrines; to contribute cheerfully and regularly to the support of the ministry, the expenses of the church, the relief of the poor, and spread of the gospel through all nations.

We also engage to maintain family and secret devotions; to religiously educate our children; to seek the salvation of our kindred and acquaintances; to walk circumspectly in the world; to be just in our dealings, faithful in our engagements, and exemplary in our deportment; to avoid all tattling, backbiting, and excessive anger; to abstain from the sale of, and use of, intoxicating drinks as a beverage, to be zealous in our efforts to advance the kingdom of our Savior.

We further engage to watch over one another in brotherly love, to remember one another in prayer; to aid one another in sickness and distress; to cultivate Christian sympathy in feeling and Christian courtesy in speech; to be slow to take offense, but always ready for reconciliation and mindful of the rules of our Savior to secure it without delay.

We moreover engage that when we remove from this place we will, as soon as possible, unite with some other church where we can carry out the spirit of this covenant and the principles of God's Word.

Big Emory Baptist Association Constitution

Article I – NAME

This Body shall be called The Big Emory Baptist Association.

Article II – PURPOSE

The Mission of the Big Emory Baptist Association is to assist Churches in fulfilling the Great Commission through Prayer, Evangelism, Discipleship, Ministry, Fellowship, and Worship.

Article III – POWERS

SECTION A. This Association shall have no ecclesiastical power or jurisdiction whatever over the churches represented in this body.

SECTION B. This Association shall have the power to provide rules for its own government and to determine the basis of representation in its body. ROBERT’S RULES OF ORDER (Latest Edition) will be used as the parliamentary guide for all deliberations of the Association.

SECTION C. It shall also have power to seat by a majority vote messengers of affiliated churches whose practice and conduct are in keeping with the aims and objects of this body.

Article IV – REPRESENTATION

SECTION A. The Annual Session of this body shall be held on the fourth Thursday of October at a place and hour mutually agreed upon. The Moderator may call Special Meetings of the association by sending at least two weeks’ written notice to the churches, their pastors, and all Executive Board members. The letter must state the time, place, and purpose of the Special Meeting.

SECTION B. Any Baptist church whose practice, articles of faith, and policy are in accord with those of this association shall be entitled to representation in this body.

SECTION C. The basis of representation shall be two (2) messengers for every affiliated church plus one (1) additional messenger for every fifty (50) resident members or fractional part thereof, not to exceed ten (10) for any one (1) church. A quorum shall consist of those present from the cooperating churches at the Annual Meeting in order to transact business.

Article V – OFFICERS

The Officers of this body shall be a Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer and Assistant Treasurer; each of whom shall be elected annually. They shall assume their duties at the conclusion of the Association Annual Meeting. The Moderator and Assistant Moderator shall serve no more than two (2) years in succession in their respective offices. The Director of Missions is an ex-officio officer of the association.

Article VI – DUTIES OF OFFICERS

SECTION A. It shall be the duty of the Moderator to preside over the Associational Annual Meeting, Special Meetings, and Executive Board meetings, to keep order, and to appoint special Committees as directed by the body.

SECTION B. It shall be the duty of the Clerk to keep a record of the proceedings of The Association Annual Meeting, Special Meetings, and Executive Board Meetings, and to furnish the same to the Journal Committee for publication.

SECTION C. It shall be the duty of the Treasurer to keep all funds of the Association and disburse the same upon the order of the body.

SECTION D. It shall be the duty of the Director of Missions to lead the Association in accordance to the approved job description. Whenever there is a vacancy in the Director of Missions position, the Associational officers shall meet to recruit and nominate a search Committee to be approved by the Executive Board. The Director of Missions Search Committee shall be responsible to recommend to the association an Interim Director of Missions (if needed) who shall be approved by the Executive Board. The search Committee shall seek out and recommend a suitable candidate to serve as Director of Missions. Election as Director of Missions requires a three-fourths vote of the association in its Annual Meeting or at a Special Meeting of the Association called for this purpose.

Article VII – COMMITTEES AND JOB DESCRIPTIONS

All Committees are to function during the entire associational year in the areas assigned to them either by their job description or by special assignments given them by the Executive Board at any time during the year.

I. THE ASSOCIATION COMMITTEES:

1. Shall consist of the Trustee Committee; Properties Committee; Nominating Committee; Administrative Committee; Program Committee; and the Church and Community Ministries Committee. The Director of Missions and the Moderator; Assistant Moderator; Clerk and Treasurer shall be ex-officio members of each Committee with a voice and a vote.
2. Committee leaders are responsible to secure for their Committee the number of Committee members necessary to accomplish the Committee's task.
3. Committee Leaders shall be elected annually by the Messengers at the Association Meeting in October.

II. These Committees shall also consist of "subordinate Committee Leaders" as follows:

a. Administrative Committee (Association Moderator is Committee Leader)

- 1) Budget and Finance Committee
- 2) Personnel Committee
- 3) Minister Assistance Committee
- 4) Historical Committee
- 5) Journal Committee

b. Program Committee (DOM is Committee Leader)

- 1) Discipleship Committee
- 2) Evangelism Committee
- 3) Library Committee
- 4) Music Committee
- 5) Prayer Committee
- 6) Seminary Extension Committee
- 7) Sunday School Committee
- 8) Vacation Bible School Committee
- 9) Youth Evangelism Committee

c. Church and Community Ministries Committee (DOM is Committee Leader)

- 1) Baptist Collegiate Ministry Committee
- 2) Disaster Relief Committee
- 3) Men's Ministry Committee (including RA's and Challengers)
- 4) Missions Committee
- 5) Rebuild Ministry Committee
- 6) Storehouse Ministry Center Committee
- 7) WMU Committee

Committees:

- 1- Shall be responsible for developing and coordinating the basic ongoing programs of the association on both a short and long range basis.
- 2- Shall make assignments of program responsibilities to particular directors, groups, or Committees, which shall report to the Executive Board on progress and development; and, through the Executive Board, to the Association.
- 3- The DOM and the Moderator, in conjunction or consultation with the Committee leaders, shall be responsible for planning the Program for the Annual Meeting of the Association.
- 4- The Moderator at times of need shall appoint the Constitution Committee and the Credentials Committee.

SECTION A. THE ASSOCIATION TRUSTEES

- 1- The title to all property owned by the association is vested in three (3) trustees who are elected by the association in its Annual Session. The definition of a trustee is:
- 2- "...a person appointed...to execute a trust, one in whom an estate, interest, or power is vested...to administer or exercise it for the benefit or to the use of another. (He) is a person who holds the title and administers it for others' benefit."
- 3- The three (3) trustees for the association are entrusted with its property solely for its benefit. The transfer of the property of the association can be conveyed only by the trustees acting upon a motion duly made and adopted by the association or by the power delegated to its Executive Board.
- 4- The Trustees shall serve a three year term, with one Trustee rotating off each year.

SECTION B. THE PROPERTIES COMMITTEE

- 1- Shall regularly inspect and give supervision to maintenance and upkeep of all properties owned by the association within prescribed budget guidelines.
- 2- Shall recommend to the Executive Board proposals for any major changes in structure, modernization of existing structures, or construction of additional facilities.
- 3- Shall have the responsibility for establishing guidelines for the use of, and changes in the use of, all properties owned by the Association.

SECTION C. THE NOMINATING COMMITTEE

- 1- Shall present to the Executive Board and/or Annual Session of the association the names of persons committed to serve for the new associational year in any office necessary to the orderly function of the association.
- 2- Shall present to the Executive Board recommendations for filling any vacancies in standing Committees occurring during the year.

NOTE: The offices of Moderator, Assistant Moderator, and employed personnel shall be excluded from the above guidelines.

- 3- Two members shall be elected at the Annual Meeting. Nominations for the Nominating Committee shall be the responsibility of the Moderator and the DOM.
- 4- Shall consist of a six member Committee with two members rotating off every year (see #3 above). Each member will serve three full years, unless otherwise stated because of fulfilling an unexpired term.

Administrative Committees

SECTION D. THE BUDGET AND FINANCE COMMITTEE

- 1- Shall have the Association Treasurer and Assistant Treasurer as two (2) of its members.
- 2- Shall present a proposed annual budget as an item of information to the Executive Board, no later than the Executive Board meeting before the Annual Meeting. After the budget has been adopted by the association in its Annual Meeting, any changes which are proposed to the adopted budget shall first be referred to this Committee and any changes shall be recommended to the Executive Board for approval.

SECTION E. THE PERSONNEL COMMITTEE

- 1- Shall serve as an advisory body to director of missions and as liaison between the Director of Missions and the Executive Board of the association.
- 2- Shall serve as an advisory body to the director of missions in giving supervision to all other personnel employed by the association.
- 3- Review annually the job performance of all Association employees and recommend proposed salaries to the Budget and Finance Committee.
- 4- Shall have the responsibility for recommending employment of all personnel other than the Director of Missions.

SECTION F. THE MINISTERS ASSISTANCE COMMITTEE

- 1- The Committee shall have the responsibility of receiving and giving consideration to requests for assistance to any person who had been serving in a paid, church related ministry position, in a church that is related to the Big Emory Baptist Association, and who has experienced forced termination or resignation.
- 2- All requests for such assistance shall be directed to or referred to this Committee.
- 3- The terminated person may be assisted with expenses to attend the Career Assessment Program at the LifeWay Christian Resources.
- 4- Funding for this assistance shall be through the association budget. Funding shall be cumulative with unused amounts being deposited in a savings account up to a maximum of \$6000. These funds shall be disbursed and accounted for through the normal financial processes of Big Emory Baptist Association.

SECTION G. THE HISTORICAL COMMITTEE

- 1- Shall seek and maintain an updated historical record of the association.
- 2- Shall seek to secure annually from the individual churches information concerning events, activities, and programs occurring during the year which might be of joint interest to all the churches; and to include such in a report to the Annual Meeting.
- 3- The Committee shall consist of the association administrative assistant, the director of missions, and the association clerk.

SECTION H. THE JOURNAL COMMITTEE

- 1- Shall study the draft of the Minutes of the Annual Sessions as prepared by the clerk, and agree upon the accuracy of these Minutes.
- 2- Shall organize the Proceedings of the Annual Sessions into booklet form and cause them to be published in as timely and economical a fashion as possible.
- 3- Shall have the association clerk as a member. In case the assistant clerk is responsible for recording the minutes of the Annual Meeting, he/she shall serve in place of the clerk.

Program Committees

SECTION I. THE DISCIPLESHIP TRAINING COMMITTEE

- 1- Shall offer Discipleship Training events, clinics, and opportunities in the Association in conjunction with the Churches.
- 2- Shall encourage Churches to be involved in Discipleship Training.

SECTION J. THE EVANGELISM COMMITTEE

- 1- Shall plan and promote annual evangelism conferences and events for the Association.
- 2- Shall seek to provide encouragement and aid to undergird evangelism efforts in all the churches throughout the year

SECTION K. THE LIBRARY COMMITTEE

- 1- Shall plan, implement, and promote the use of Church Media Libraries in the work of the Association and its individual Churches.
- 2- Shall offer assistance to Churches in organizing and operating Church Libraries and media resources.

SECTION L. THE MUSIC COMMITTEE

- 1- Shall arrange for the provision of music at Associational functions according to the particular requirements of the function and/or the request of the organizing Committee of the meeting or the Moderator or Director of Missions.
- 2- Shall arrange for music for worship at the Annual Meeting of the Association

SECTION M. THE PRAYER COMMITTEE

- 1 – Shall be elected by the Association at the annual meeting.
- 2 – Shall consist of the Committee Leader, who will serve a term of 3 years after which time a new Committee Leader shall be elected, and the number of Committee members deemed necessary for the Committee to accomplish its goals.
- 3 – The purpose of the Prayer Committee shall be to meet regularly, encourage Churches association wide to pray specifically for issues brought to its attention, and to encourage a deeper prayer life for the members of our association

SECTION N. THE SEMINARY EXTENSION COMMITTEE

- 1- Shall serve as coordinator for any program or activity involving the association and Seminary Extension of the SBC.
- 2- Shall plan, supervise, and promote any seminary extension program sponsored by the association.

SECTION O. THE SUNDAY SCHOOL COMMITTEE

- 1- Shall offer clinics in the Association with the aim of improving Sunday School attendance.
- 2- Shall assist the Churches of the Association in promoting the evangelistic work of the Sunday School as the primary evangelistic tool of the Churches.

SECTION P. THE VACATION BIBLE SCHOOL COMMITTEE

- 1- Shall support VBS by offering clinics and other appropriate activities.
- 2- Shall promote VBS in the Association and among the Churches of the Association, and shall plan, coordinate, and implement an annual VBS clinic in the Association.
- 3- Shall, at the conclusion of the VBS season, collect, and record information provided by the Churches in connection with their VBS attendance, offerings, and decisions.

SECTION Q. THE YOUTH EVANGELISM COMMITTEE

- 1- Shall plan and promote the Annual Youth Evangelism Conference, and other events.
- 2- Shall be responsible for collecting and disbursing funds for the personalities and facilities of the Youth Evangelism Conference.

SECTION Z. THE CONSTITUTION COMMITTEE

- 1- Shall be appointed by the Moderator when necessary and shall consist of no less than three members.
- 2- Shall study the needs of the association Constitution and make needed recommendations for revisions to the Annual Meeting of the association.
- 3- Shall serve as a clearing Committee for recommended changes to the constitution: but, at no time shall this be construed to mean that needed revisions cannot be brought to the floor by any messenger in The Annual Sessions of the association. The Committee has the freedom of time – not to exceed two (2) years – to present a recommended change, and is not bound to present changes brought to it by members.
- 4- Shall meet periodically, at the request of the Moderator or Director of Missions, to review the various procedures and practices of the association, and make regular reports to the Executive Board.
- 5- Shall give advance notice which is as far reaching and wide ranging as possible of any/all constitutional changes which are recommended. However, recommended revisions which are presented to the Executive Board no later than its September meeting shall be construed as “advance notice” which is to be given to the Annual Meeting of the association. by this Committee.

Article VIII – DUTIES OF CHURCHES

SECTION A. Churches represented in this association shall report to the association by completing the (ACP) Annual Church Profile and making every effort to meet the requested date.

SECTION B. It shall be the duty of each church represented in the association to pay a reasonable part in supporting the ministries of the association.

Article IX – THE EXECUTIVE BOARD

The Executive Board shall be composed of all elected officers of the association plus two (2) messengers from each cooperating church that is in fellowship with the association (as well as the Pastor of those cooperating churches, who shall have voting privileges as ex-officio representatives of their respective churches). All messengers from the churches shall be elected by the church of which they are members. They shall be elected to serve for one (1) year, and their names shall be reported to the association on the (ACP) Annual Church Profile. Changes in the names of messengers from the churches can be made by official church action and notification to the Executive Board, subject to the criteria given above.

The Executive Board shall be subject to the orders of the association; and none of its acts shall conflict with action taken by the association in either its Annual Meeting or Special Meetings.

The presence of elected Executive Board members shall constitute a quorum in conducting business. Regular meetings shall be held at a time, place, and date set by the Executive Board.

The Executive Board shall have the responsibility of the work of the association between Annual Sessions. The minutes of each meeting shall be presented to the association in each Annual Meeting.

The Executive Board shall not usurp the authority given by the Constitution or the association in session to any Committee, program body of personnel, including the DOM.

Article X – AMENDMENTS

This Constitution may not be amended at any time until the amendment is read at an Executive Board meeting prior to the Annual Meeting, with the vote being taken in the Annual Meeting. A two-thirds (2/3) majority vote of those present and voting is required to adopt any/all changes to this Constitution.

On June 5th 2022, five members of the Navajo mission team left the BEBA office at 5am headed for Red Valley AZ. They went out a week early to add an addition on to the kitchen at Lily of the Valley Church. The addition was for a sink with running water in the kitchen. That task was accomplished by Sunday evening. The members of the church were very thankful.

On Saturday evening June 11th the remaining team members arrived. On Sunday morning the mission team and the Navajo people went up on the mountain for our worship time. We had a wonderful service with beautiful views down into the valley.

Monday morning was the start of VBS and the mission of handing out buckets. VBS got off to a slow start. Monday we only had 2 for VBS. By the time we reached Thursday we had 24. The handing out of the buckets was a few in one place, then a lot in another place.

It had been 2 years since we had been to Red Valley and they still had a mask mandate. Which made it hard at times.

We had a worship service every night. There would be a few Navajo attending. On Thursday night was our carnival night. We had approximately 100 in attendance. You could feel the Holy Spirit. We had people in line so they could pray with someone. The children enjoyed all the games and bounce house that night. It was an amazing night.

Plans were in the works for next years trip before we ever left Red Valley.

We hope and pray we made things a little better for our Navajo family and that we planted seeds to see souls saved.

Ministries of Executive Board 2021 - 2022

Baptist & Reflector

The Baptist and Reflector continues to strive to produce articles and columns that impact Tennessee Baptist Convention churches. A major emphasis this year has been an emphasis on the Five Objectives and how are states are still dealing with COVID and how it has caused additional stress on pastors and our churches. The paper provided extensive coverage of the impact of the Supreme Court's reversal of Roe v. Wade and the Southern Baptist Convention's decision to adopt the Sexual Abuse Task Force. The B&R also has provided coverage of Tennessee Baptist's Sexual Abuse Task Force and will include coverage of their report during this year's Summit in Memphis.

The B&R is mailed to more than 16,000 homes 26 weeks a year, reaching nearly 40,000 readers.

In addition, the B&R website has grown steadily since it was introduced in late 2015. Numbers are incomplete for 2022 but in 2021, we sent our 47 E-newsletters reaching a potential audience of more than 20,000 people for each newsletter. During that year we had more than 400,000 pages views and nearly 200,000 site visitors.

The goal of the paper is to “tell the story of Tennessee Baptists” through news, feature stories and photographs. As in the past, the paper this year placed a major emphasis on what Tennessee Baptists are doing to reach the world for Christ by focusing on stories related to missions and evangelism. This year the paper has focused on timely topics such as domestic violence that impact Tennessee Baptists and our churches.

The Baptist and Reflector continued to utilize social media tools in 2022 such as Twitter. Editor Lonnie Wilkey regularly writes a blog that provides information for Tennessee Baptists between print issues.

The staff monitors trends that could affect Tennessee Baptists and prints those stories to keep readers informed. In addition, opinions, both from the editor and others, are printed and are intended to make readers think, reflect, and act.

The paper continually seeks to enlist new subscribers. We need more churches to send the paper to their leadership such as deacons, Sunday School teachers, etc. We are asking every reader of the *B&R* for the next year to consider sending one subscription to someone they know. *If just a small percentage of our readers would do this, our print circulation would significantly increase. Baptist Memorial Health Care System

Memphis, Tennessee

Baptist Memorial Health Care began as a 150-bed hospital in downtown Memphis in 1912. It was formed by the Southern Baptist Conventions of Tennessee, Mississippi and Arkansas because they recognized a tremendous need for a health care facility in this part of the country. The hospital's early days were rough – at one point, it almost closed – but eventually it grew to become the largest private hospital in the world. The hospital played a very important role in the history of health care in the 20th century, celebrating many firsts along the way.

The Baptist Memorial Health Care system was created in 1981 to provide an integrated health care delivery system offering a full continuum of care to communities throughout the Mid-South. Today, a total of 22 hospitals in Arkansas, Tennessee and Mississippi; an 800-member physician group; and dozens of other entities are affiliated with Baptist.

Baptist Memorial Health Care's staff chaplains are a part of the health care team. Patients, family members or employees know that they can ask for a chaplain at any time to augment our health care with spiritual or emotional care. In our hospitals, our chaplains represent their own faith but often deal with spiritual issues that transcend denominational lines.

In August 2017, Baptist's Pastoral Care Department introduced the Rev. Jimmy Terry Preaching Series. The series is named in memory of a beloved member of Baptist's Board of Trustees and the founder and former pastor of Tabernacle Baptist Church in Clarksville, Tennessee. Each month, a speaker – usually an ordained Baptist minister – delivers an evangelical message to employees, physicians, patients and visitors at Baptist's flagship hospital. The message is also broadcast to all 22 of Baptist's hospitals in Tennessee, Mississippi and Arkansas, and it is promoted on Baptist's Facebook page. During the past year, these Facebook posts reached 50,000 people, and the videos were viewed 49,000 times.

This fall, Baptist will open West Tennessee's first freestanding emergency department in Arlington, Tennessee, providing exceptional emergency services to an under-served area. The \$16 million state-of-the-art emergency department measures 35,000 square feet and includes eight patient rooms, CT scan, X-ray and ultrasound imaging technology. A Baptist Medical Group primary care office and a helipad will be built next to the new facility.

Baptist donated the former McKenzie Regional Hospital building and grounds, valued at \$1.29 million, to the McKenzie Industrial Board. The property will help spearhead economic growth and development for the community. In 2018, Baptist purchased McKenzie Regional's buildings, land, equipment and ambulance service from Quorum Health Corporation to preserve health care in the region. Baptist maintained outpatient services in McKenzie and expanded services at Baptist Carroll County in nearby Huntingdon, Tennessee.

U.S. News & World Report ranked Baptist Memphis No. 1 in the metro-Memphis area and No. 3 in Tennessee in its 2022-23 Best Hospitals rankings. For this year's rankings, U.S. News evaluated more than 4,500 hospitals across 15 specialties and 20 procedures and conditions. Baptist Memphis, along with Baptist Union City, earned several "High Performing" ratings.

Associational Report 2022

Our partnership with Tennessee Baptists enables us to fulfill our mission as we serve our community, the marketplace, and the Church. Our distinctive Christ-centered approach to education is designed to equip students to leave C-N loving Jesus more and trusting the Scripture more.

This past year has included:

- The University completed our first year of a five-year strategic plan entitled *Acorns to Oaks: Pursuing God's Preferred Future, marked by beginning construction of the Drama and Ted Russell Center, future home of C-N's nursing program.*
- At the opening of the 2021-22 academic year, the University posted an enrollment of 2,835 students, the second highest in Carson-Newman's history.
- Carson-Newman was named a "Best Regional College" by Princeton Review. U.S. News & World Report ranked C-N's online graduate education program No. 2 in the state and No. 1 among Tennessee private institutions.
- The University's Board of Trustees approved the new College of Professional Studies which launched fall 2022. It's designed to serve adult and professional students with a distinctive Christ-centered approach to education across the southeast.
- C-N changed the name of its "School of Religion" to "School of Biblical and Theological Studies," as well as launched a Master of Divinity degree this fall.
- Thankfully we saw God work by continuing to draw students to saving faith in Jesus Christ last year. This gave us the opportunity to hold a baptismal service in Mossy Creek.
- C-N's Campus Ministries partnered with GenSend, a North American Mission Board initiative, and sent three mission teams to Denver, Pittsburgh, and New Orleans during Spring Break. During summer 2022, students continued to serve in Denver and Pittsburgh, as well as missions in Jamaica, Nicaragua, and the Dominican Republic.
- More than 500 C-N students, faculty and staff participated in the University's annual Day of Service, taking part in projects across Jefferson, Hamblen, Blount, Grainger, and Knox counties.
- For the academic year, C-N students spent 21,500 hours involved in community service and outreach.
- C-N began a Delight Ministry chapter on campus, a nationwide organization with Bible studies and discipleship groups for college women.
- University renamed its "Appalachian Outreach Ministries" to "Appalachian Ministries of the Smokies" (AMOS).
- Carson-Newman honored Long Hollow Church Senior Pastor Robby Gallaty with the inaugural Ken Sparks Award. The presentation took place during the 2021 TBC Summit in Brentwood.
- Carson-Newman's Christ-centered education was the focus of an episode of *The College Tour, Season 3. The series and C-N's 30-minute episode are featured on Amazon Prime, Roku, Apple TV, and other platforms.*
- Chapel services are on Tuesdays at 9:30 during the fall and spring semesters. We would love to encourage Tennessee Baptists to worship us when you can.

Students from across the globe are The Academy's most distinctive feature, with over 1,100 students and 99 nations represented since 1935. The King's Academy is experiencing a 500% increase in the amount of new international boarding students during 2022-23 academic year while also experiencing a growth in the program as a whole after graduating over seventy percent of boarding students in the 2021-22 academic year. Students currently enrolled represent the following nations: Aruba, Brazil, China, Czech Republic, Croatia, Curaçao, Italy, Japan, Montenegro, and Rwanda.

The greatest news to report regarding The King's Academy from the previous academic year is that forty-three students accepted Jesus Christ as their Lord and Savior. Academy staff worked diligently to disciple and partner with local churches to ensure that students were plugged into the local body of Christ. The Spirit is at work on campus in Seymour, Tennessee, and we pray for further movement towards life change.

The Academy remains devoted to developing servant leaders that will change the world for Christ. Beginning in 2021, TKA launched its' "Love Where We Live" initiative that focuses on servant leadership opportunities for students in K3-12th grade. Academy students logged over 500 service hours as they served communities throughout East Tennessee. By serving others, students are learning the value of a mission minded lifestyle while also learning about the world that the Lord has created.

The King's Academy is honored to announce that at the start of the academic year, The Academy is experiencing continued enrollment growth for the second year in a row coming off the global pandemic. The Academy is set to begin the year with a 5% increase from the previous, and a total increase of 12% increase over the past two years. Leadership continues to focus on growing the international program, which was hit the hardest due to the pandemic, while being greatly encouraged by the local day student growth and reach into the local community.

The 2021-22 academic year also saw the largest increase in community support and giving, as leadership has worked diligently to make much needed capital improvements to the aging campus infrastructure. Along with the Board of Trustees, campus leadership is working to develop long term plans to accommodate current and anticipated growth in the near future.

Report to Associations, 2022**

I am happy to report that we have had only a few infections of Covid-19 in our homes. That is because of the faithful men and women who serve as direct care providers in our six group homes. As always, I remain grateful and appreciative for their diligence and vigilance as they joyfully “*Show What Love Is.*” *As of this date (July 21, 2022), Tennessee has the fifth lowest rate of vaccination, has a 25% infection rate, has a death rate from Covid that is double the national rate and we are again considered “high risk.” So, we will remain vigilant as we continue to ride the roller coaster that is Covid-19.*

The SOAR fund (Supplying Ongoing Aid to Residents) that was established through the Tennessee Baptist Foundation in 2019 has suffered losses, just as everyone who has investments anywhere. It is our hope and prayer that we will not need to invade the SOAR fund as we continue our development of Baptist Village Humboldt. Baptist Village Humboldt is well underway, and we are getting excited about opening our first two buildings in the coming months. When completed, Baptist Village Humboldt will have 10 duplex buildings (a total of 20 units) for financially needy seniors. We will give priority of placement in these units to retired Baptist pastors and missionaries.

We have had to cancel Special Friends Camp now for three years in a row due to our inability to find Counselors. Evidently, most camps everywhere are having the same difficulty in finding young people for staff. Due to these losses, TBAH has determined that we will not seek to have Special Friends Camp for the foreseeable future and possibly ever again.

Our Father’s Day Offering receipts are pretty much on target to come in at a rate consistent with previous years. As always, we are hopeful that we will exceed our goal and avoid using any further reserves, thus allowing us to fund deferred maintenance projects at our locations.

Since 1938 the Tennessee Baptist Foundation has been of service to Tennessee Baptists and Kingdom causes around the world. The assets under management of the Foundation have grown from \$6,577 to \$162 million during that time. God continues to bless this ministry and we are pleased to make our report to the associations as to highlights for the fiscal year 2021-22 thus far. The Foundation is pleased to offer the following services to Tennessee Baptists:

- Presenting informational Faith-based estate planning seminars for churches
- Working with individuals, helping them develop distinctively Christian personal estate plans
- Assisting individuals in their establishment of various Charitable Trusts
- Striving as Trustee of trusts and funds committed to its care
- Providing investment services to Tennessee Baptist churches, associations and institutions
- Helping churches establish Legacy Ministries
- Facilitating loans to Tennessee Baptist churches/associations
- Providing grants for qualifying new ministries and projects

Highlights of the Foundation's stewardship thus far for this fiscal year include:

Funds under management: Over 1,100

Assets under management: \$162,355,269 (as of June 30, 2022)

New fund additions as of June 30, 2022: \$1,706,781 (15 new funds)

Educational scholarships: 176 - totaling \$149,000 for 2022-2023 academic year. (Awarded over \$6.1 million in scholarships since 1987)

Special Project Grants: As of June 30, 2022, we have distributed \$62,700 to assist 9 ministry projects.

Cooperative Program: \$332,675 as of June 30, 2022. Projected to give over \$600,000 by year end.

WMU Tennessee Woman's Missionary Union 2022 Annual Report

In 2021-22, Tennessee WMU challenged Tennessee Baptists to be relentless in living authentic faith in Christ, seeking God in prayer, giving sacrificially, and witnessing to others. This report shares information about some of the state events, ministries, and initiatives that have taken place.

Tennessee WMU launched the Tennessee Youth Venture Team in the fall of 2021 to replace the former State Acteens Advisory Panel. The high school students chosen to serve each year are challenged, disciplined, and mentored in a missions lifestyle. The students on the 2021-22 Venture Team were Noah Crook, Grayce McEarl, Pierce McNew, Haylin Ownby, and Avery Pace.

Over 350 boys, leaders, and personnel attended the 2021 RA Camp-O-Ree at Linden Valley Baptist Conference Center on October 15-17. This missions camping event for boys grades 1-12 is hosted by Mid-South Royal Ambassadors and Tennessee WMU.

Tennessee WMU produced a missions event kit for children in grades 1-6 with an 80's theme feel, "Jammin' in a Box." The event kit included a Bible lesson, missions lesson, and suggestions for crafts, games, and mission projects. Seventy-five event kits were purchased by or given to churches across the state to utilize.

2022 Missions Get-Together was held at the Gatlinburg Convention Center on April 1-3, with a total attendance of 773 people representing over 175 churches. Through the event ministry project, participants brought more than 15,000 items and \$2,660 in gift cards and cash that will be used to minister to refugee families across the state and international students working in the Gatlinburg/Pigeon Forge resort ministries area

The 2022 Tennessee WMU Annual Meeting occurred on April 2 during the Saturday morning general session of Missions Get-Together in Gatlinburg. The meeting included highlights of the work of Tennessee WMU and the election of 2022-23 state officers and new Executive Board members.

In April 2022, \$39,700 in scholarships were awarded by the Tennessee WMU Executive Board to 43 students attending graduate school, seminary, and undergraduate schools in Tennessee during the 2022-23 school year. These scholarships are funded through endowments, invested funds, and the Golden Offering for Tennessee Missions.

Christian Women's Job Corps and Christian Men's Job Corps are ministries of WMU that seek to help men and women break the cycle of poverty through job and life skill classes, Bible study, and mentoring. We currently have 20 sites (14 CWJC and 6 CMJC) in 13 locations across the state. Begin Anew of Middle TN celebrated 25 years of ministry in 2022 as it was the first CWJC site started in Tennessee.

The 2021-22 Tennessee Missions Emphasis theme was "Same Jesus. Sharing Hope and Truth." The 2021-22 Golden Offering for Tennessee Missions goal was \$2,100,000, and the total amount given as of July 21, 2022, was \$2,124,958. Besides this year's offering being the highest amount given in the 120-year history of the Golden Offering, it is also the first time since 2007-08 that Tennessee Baptists have reached the goal for the Golden Offering.

For we are laborers together with God, encouraging and equipping churches and individuals to engage in missions learning and involvement that enables them to fulfill the Great Commission.

- The LifeShape Scholarship is a major gift to Union that will help recruit some of the brightest students in the humanities and social sciences.
