## **ABBREVIATED FORM OF THE ARTICLES OF FAITH**

### **The Scriptures**

- I. We believe that the holy Bible was written by men divinely inspired, that it is the truth without mixture and error; and that it is the standard by which all human conduct and creeds should be tried. II Timothy 3:15-17.

### **The True God**

- II. We believe that there is one and only one True and Living God; that in the Unity of the Godhead there are three persons; the Father, the Son, the Holy Spirit. John 4:24; 10:30.

### **The Fall of Man**

- III. We believe that man was created in holiness, but by voluntary transgression fell from that holy state, in consequences of which all mankind are now sinners and are under condemnation of eternal ruin. Genesis 1:27, Romans 5:11.

### **The Way of Salvation**

- IV. We believe that the salvation of sinners is wholly of grace through the atoning death and bodily resurrection of Jesus Christ. Ephesians 2:8, Isaiah 53:4, Hebrews 7:25.
- V. We believe that through Justification the perfect righteousness of God is imputed to the believers in Christ Jesus. Acts 13:39, Romans 5:12.

### **The Freeness of Salvation**

- VI. We believe that the blessings of salvation are made free to all by the Gospel, and that nothing prevents the salvation of the greatest sinner but his own depravity and rejection of the Gospel. Isaiah 55:1, John 3:16.

### **Grace in Regeneration**

- VII. We believe that in order to be saved, sinners must be regenerated or born again through the work of the Holy Spirit. John 3:3, II Corinthians 6:17.

### **Repentance and Faith**

- VIII. We believe that repentance and faith are inseparable graces, wrought in our souls by the regenerating Spirit of God, and are essential steps in salvation. Mark 1:15, Romans 10:9.

### **God's Purpose and Election**

- IX. We believe that Election is the eternal purpose of God, according to which He graciously regenerates, sanctifies, and saves sinners; and that this is consistent with the free agency of man. Romans 8:28-31, II Peter 1:10-11.

### **Sanctification**

- X. We believe that Sanctification is progressive process by which the believer is made partaker of God's Holiness, and that this process begins in regeneration. I Thessalonians 4:3 and that is carried on in the hearts of believers, by the presence and power of the Holy Spirit. Philippians 2:12-13.

## **ABBREVIATED FORM OF THE ARTICLES OF FAITH**

### **The Perseverance of Saints**

- XI. We believe that only real believers endure to the end, and that they are kept by the power of God through faith in Jesus Christ. Romans 8:32-39, II Timothy 1:12.

### **A Gospel Church**

- XII. We believe that a Church of Christ is a congregation of baptized believers bound together in the faith and fellowship of the Gospel; and that Jesus committed the ministry of His Gospel to His churches. Acts 2:41-42.

### **Baptism and the Lord's Supper**

- XIII. We believe that baptism is the immersion of a believer in water in the name of Father, Son, Holy Ghost, and on the authority of the New Testament and a New Testament Church. That baptism is a prerequisite to the Lord's Supper and only such as have been scripturally baptized are proper subjects for the Lord's Supper. Acts 8:36, Matthew 28:19, I Corinthians 11:26.

### **The Christian Sabbath**

- XIV. We believe that the first day of the week is the Lord's Day and is to be kept sacred to religious purposes. Acts 20:7, Exodus 20:8.

### **The World to Come**

- XV. We believe at the last day Christ will descend from heaven and raise the dead; that a solemn judgement and separation will take place, and that his judgement will fix forever the final state of men in Heaven or Hell. Acts 1:11, 24:15, Matthew 13:49; 25:31-46.

## **Church Covenant**

**H**aving been led, as we believe by the Spirit of God, to receive the Lord Jesus Christ as our Savior and, on the profession of our faith, having been baptized in the name of the Father and of the Son, and of the Holy Spirit, we do now, in the presence of God, and this assembly, most solemnly and joyfully enter into covenant with one another as one body in Christ.

**We** engage, therefore, by the aid of the Holy Spirit to walk together in Christian love, to strive for the advancement of this church, in knowledge, holiness and comfort, to promote its prosperity and spirituality; to sustain its worship, ordinances, discipline, and doctrines; to contribute cheerfully and regularly to the support of the ministry, the expenses of the church, the relief of the poor, and spread of the gospel through all nations.

**We** also engage to maintain family and secret devotions; to religiously educate our children; to seek the salvation of our kindred and acquaintances; to walk circumspectly in the world; to be just in our dealings, faithful in our engagements, and exemplary in our deportment; to avoid all tattling, backbiting, and excessive anger; to abstain from the sale of, and use of, intoxicating drinks as a beverage, to be zealous in our efforts to advance the kingdom of our Savior.

**We** further engage to watch over one another in brotherly love, to remember one another in prayer; to aid one another in sickness and distress; to cultivate Christian sympathy in feeling and Christian courtesy in speech; to be slow to take offense, but always ready for reconciliation and mindful of the rules of our Savior to secure it without delay.

**We** moreover engage that when we remove from this place we will, as soon as possible, unite with some other church where we can carry out the spirit of this covenant and the principles of God's Word.

# **Big Emory Baptist Association Constitution**

## **Article I – NAME**

This Body shall be called The Big Emory Baptist Association.

## **Article II – PURPOSE**

The Mission of the Big Emory Baptist Association is to assist Churches in fulfilling the Great Commission through Prayer, Evangelism, Discipleship, Ministry, Fellowship, and Worship.

## **Article III – POWERS**

**SECTION A.** This Association shall have no ecclesiastical power or jurisdiction whatever over the churches represented in this body.

**SECTION B.** This Association shall have the power to provide rules for its own government and to determine the basis of representation in its body. ROBERT’S RULES OF ORDER (Latest Edition) will be used as the parliamentary guide for all deliberations of the Association.

**SECTION C.** It shall also have power to seat by a majority vote messengers of affiliated churches whose practice and conduct are in keeping with the aims and objects of this body.

## **Article IV – REPRESENTATION**

**SECTION A.** The Annual Session of this body shall be held on the fourth Thursday of October at a place and hour mutually agreed upon. The Moderator may call Special Meetings of the association by sending at least two weeks’ written notice to the churches, their pastors, and all Executive Board members. The letter must state the time, place, and purpose of the Special Meeting.

**SECTION B.** Any Baptist church whose practice, articles of faith, and policy are in accord with those of this association shall be entitled to representation in this body.

**SECTION C.** The basis of representation shall be two (2) messengers for every affiliated church plus one (1) additional messenger for every fifty (50) resident members or fractional part thereof, not to exceed ten (10) for any one (1) church. A quorum shall consist of those present from the cooperating churches at the Annual Meeting in order to transact business.

## **Article V – OFFICERS**

The Officers of this body shall be a Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer and Assistant Treasurer; each of whom shall be elected annually. They shall assume their duties at the conclusion of the Association Annual Meeting. The Moderator and Assistant Moderator shall serve no more than two (2) years in succession in their respective offices. The Director of Missions is an ex-officio officer of the association.

## **Article VI – DUTIES OF OFFICERS**

**SECTION A.** It shall be the duty of the Moderator to preside over the Associational Annual Meeting, Special Meetings, and Executive Board meetings, to keep order, and to appoint special Committees as directed by the body.

**SECTION B.** It shall be the duty of the Clerk to keep a record of the proceedings of The Association Annual Meeting, Special Meetings, and Executive Board Meetings, and to furnish the same to the Journal Committee for publication.

**SECTION C.** It shall be the duty of the Treasurer to keep all funds of the Association and disburse the same upon the order of the body.

**SECTION D.** It shall be the duty of the Director of Missions to lead the Association in accordance to the approved job description. Whenever there is a vacancy in the Director of Missions position, the Associational officers shall meet to recruit and nominate a search Committee to be approved by the Executive Board. The Director of Missions Search Committee shall be responsible to recommend to the association an Interim Director of Missions (if needed) who shall be approved by the Executive Board. The search Committee shall seek out and recommend a suitable candidate to serve as Director of Missions. Election as Director of Missions requires a three-fourths vote of the association in its Annual Meeting or at a Special Meeting of the Association called for this purpose.

## Article VII – COMMITTEES AND JOB DESCRIPTIONS

All Committees are to function during the entire associational year in the areas assigned to them either by their job description or by special assignments given them by the Executive Board at any time during the year.

### *I. THE ASSOCIATION COMMITTEES:*

1. Shall consist of the Trustee Committee; Properties Committee; Nominating Committee; Administrative Committee; Program Committee; and the Church and Community Ministries Committee. The Director of Missions and the Moderator; Assistant Moderator; Clerk and Treasurer shall be ex-officio members of each Committee with a voice and a vote.
2. Committee leaders are responsible to secure for their Committee the number of Committee members necessary to accomplish the Committee's task.
3. Committee Leaders shall be elected annually by the Messengers at the Association Meeting in October.

### *II. These Committees shall also consist of "subordinate Committee Leaders" as follows:*

#### a. Administrative Committee (Association Moderator is Committee Leader)

- 1) Budget and Finance Committee
- 2) Personnel Committee
- 3) Minister Assistance Committee
- 4) Historical Committee
- 5) Journal Committee

#### b. Program Committee (DOM is Committee Leader)

- 1) Discipleship Committee
- 2) Evangelism Committee
- 3) Library Committee
- 4) Music Committee
- 5) Prayer Committee
- 6) Seminary Extension Committee
- 7) Sunday School Committee
- 8) Vacation Bible School Committee
- 9) Youth Evangelism Committee

#### c. Church and Community Ministries Committee (DOM is Committee Leader)

- 1) Baptist Collegiate Ministry Committee
- 2) Disaster Relief Committee
- 3) Men's Ministry Committee (including RA's and Challengers)
- 4) Missions Committee
- 5) Rebuild Ministry Committee
- 6) Storehouse Ministry Center Committee
- 7) WMU Committee

#### Committees:

- 1- Shall be responsible for developing and coordinating the basic ongoing programs of the association on both a short and long range basis.
- 2- Shall make assignments of program responsibilities to particular directors, groups, or Committees, which shall report to the Executive Board on progress and development; and, through the Executive Board, to the Association.
- 3- The DOM and the Moderator, in conjunction or consultation with the Committee leaders, shall be responsible for planning the Program for the Annual Meeting of the Association.
- 4- The Moderator at times of need shall appoint the Constitution Committee and the Credentials Committee.

## **SECTION A. THE ASSOCIATION TRUSTEES**

- 1- The title to all property owned by the association is vested in three (3) trustees who are elected by the association in its Annual Session. The definition of a trustee is:
- 2- "...a person appointed...to execute a trust, one in whom an estate, interest, or power is vested...to administer or exercise it for the benefit or to the use of another. (He) is a person who holds the title and administers it for others' benefit."
- 3- The three (3) trustees for the association are entrusted with its property solely for its benefit. The transfer of the property of the association can be conveyed only by the trustees acting upon a motion duly made and adopted by the association or by the power delegated to its Executive Board.
- 4- The Trustees shall serve a three year term, with one Trustee rotating off each year.

## **SECTION B. THE PROPERTIES COMMITTEE**

- 1- Shall regularly inspect and give supervision to maintenance and upkeep of all properties owned by the association within prescribed budget guidelines.
- 2- Shall recommend to the Executive Board proposals for any major changes in structure, modernization of existing structures, or construction of additional facilities.
- 3- Shall have the responsibility for establishing guidelines for the use of, and changes in the use of, all properties owned by the Association.

## **SECTION C. THE NOMINATING COMMITTEE**

- 1- Shall present to the Executive Board and/or Annual Session of the association the names of persons committed to serve for the new associational year in any office necessary to the orderly function of the association.
- 2- Shall present to the Executive Board recommendations for filling any vacancies in standing Committees occurring during the year.

NOTE: The offices of Moderator, Assistant Moderator, and employed personnel shall be excluded from the above guidelines.

- 3- Two members shall be elected at the Annual Meeting. Nominations for the Nominating Committee shall be the responsibility of the Moderator and the DOM.
- 4- Shall consist of a six member Committee with two members rotating off every year (see #3 above). Each member will serve three full years, unless otherwise stated because of fulfilling an unexpired term.

## **Administrative Committees**

## **SECTION D. THE BUDGET AND FINANCE COMMITTEE**

- 1- Shall have the Association Treasurer and Assistant Treasurer as two (2) of its members.
- 2- Shall present a proposed annual budget as an item of information to the Executive Board, no later than the Executive Board meeting before the Annual Meeting. After the budget has been adopted by the association in its Annual Meeting, any changes which are proposed to the adopted budget shall first be referred to this Committee and any changes shall be recommended to the Executive Board for approval.

## **SECTION E. THE PERSONNEL COMMITTEE**

- 1- Shall serve as an advisory body to director of missions and as liaison between the Director of Missions and the Executive Board of the association.
- 2- Shall serve as an advisory body to the director of missions in giving supervision to all other personnel employed by the association.
- 3- Review annually the job performance of all Association employees and recommend proposed salaries to the Budget and Finance Committee.
- 4- Shall have the responsibility for recommending employment of all personnel other than the Director of Missions.

## **SECTION F. THE MINISTERS ASSISTANCE COMMITTEE**

- 1- The Committee shall have the responsibility of receiving and giving consideration to requests for assistance to any person who had been serving in a paid, church related ministry position, in a church that is related to the Big Emory Baptist Association, and who has experienced forced termination or resignation.
- 2- All requests for such assistance shall be directed to or referred to this Committee.
- 3- The terminated person may be assisted with expenses to attend the Career Assessment Program at the LifeWay Christian Resources.
- 4- Funding for this assistance shall be through the association budget. Funding shall be cumulative with unused amounts being deposited in a savings account up to a maximum of \$6000. These funds shall be disbursed and accounted for through the normal financial processes of Big Emory Baptist Association.

## **SECTION G. THE HISTORICAL COMMITTEE**

- 1- Shall seek and maintain an updated historical record of the association.
- 2- Shall seek to secure annually from the individual churches information concerning events, activities, and programs occurring during the year which might be of joint interest to all the churches; and to include such in a report to the Annual Meeting.
- 3- The Committee shall consist of the association administrative assistant, the director of missions, and the association clerk.

## **SECTION H. THE JOURNAL COMMITTEE**

- 1- Shall study the draft of the Minutes of the Annual Sessions as prepared by the clerk, and agree upon the accuracy of these Minutes.
- 2- Shall organize the Proceedings of the Annual Sessions into booklet form and cause them to be published in as timely and economical a fashion as possible.
- 3- Shall have the association clerk as a member. In case the assistant clerk is responsible for recording the minutes of the Annual Meeting, he/she shall serve in place of the clerk.

## **Program Committees**

## **SECTION I. THE DISCIPLESHIP TRAINING COMMITTEE**

- 1- Shall offer Discipleship Training events, clinics, and opportunities in the Association in conjunction with the Churches.
- 2- Shall encourage Churches to be involved in Discipleship Training.

## **SECTION J. THE EVANGELISM COMMITTEE**

- 1- Shall plan and promote annual evangelism conferences and events for the Association.
- 2- Shall seek to provide encouragement and aid to undergird evangelism efforts in all the churches throughout the year

## **SECTION K. THE LIBRARY COMMITTEE**

- 1- Shall plan, implement, and promote the use of Church Media Libraries in the work of the Association and its individual Churches.
- 2- Shall offer assistance to Churches in organizing and operating Church Libraries and media resources.

## **SECTION L. THE MUSIC COMMITTEE**

- 1- Shall arrange for the provision of music at Associational functions according to the particular requirements of the function and/or the request of the organizing Committee of the meeting or the Moderator or Director of Missions.
- 2- Shall arrange for music for worship at the Annual Meeting of the Association

## **SECTION M. THE PRAYER COMMITTEE**

- 1 – Shall be elected by the Association at the annual meeting.
- 2 – Shall consist of the Committee Leader, who will serve a term of 3 years after which time a new Committee Leader shall be elected, and the number of Committee members deemed necessary for the Committee to accomplish its goals.
- 3 – The purpose of the Prayer Committee shall be to meet regularly, encourage Churches association wide to pray specifically for issues brought to its attention, and to encourage a deeper prayer life for the members of our association

## **SECTION N. THE SEMINARY EXTENSION COMMITTEE**

- 1- Shall serve as coordinator for any program or activity involving the association and Seminary Extension of the SBC.
- 2- Shall plan, supervise, and promote any seminary extension program sponsored by the association.

## **SECTION O. THE SUNDAY SCHOOL COMMITTEE**

- 1- Shall offer clinics in the Association with the aim of improving Sunday School attendance.
- 2- Shall assist the Churches of the Association in promoting the evangelistic work of the Sunday School as the primary evangelistic tool of the Churches.

## **SECTION P. THE VACATION BIBLE SCHOOL COMMITTEE**

- 1- Shall support VBS by offering clinics and other appropriate activities.
- 2- Shall promote VBS in the Association and among the Churches of the Association, and shall plan, coordinate, and implement an annual VBS clinic in the Association.
- 3- Shall, at the conclusion of the VBS season, collect, and record information provided by the Churches in connection with their VBS attendance, offerings, and decisions.

## **SECTION Q. THE YOUTH EVANGELISM COMMITTEE**

- 1- Shall plan and promote the Annual Youth Evangelism Conference, and other events.
- 2- Shall be responsible for collecting and disbursing funds for the personalities and facilities of the Youth Evangelism Conference.

## **SECTION Z. THE CONSTITUTION COMMITTEE**

- 1- Shall be appointed by the Moderator when necessary and shall consist of no less than three members.
- 2- Shall study the needs of the association Constitution and make needed recommendations for revisions to the Annual Meeting of the association.
- 3- Shall serve as a clearing Committee for recommended changes to the constitution: but, at no time shall this be construed to mean that needed revisions cannot be brought to the floor by any messenger in The Annual Sessions of the association. The Committee has the freedom of time – not to exceed two (2) years – to present a recommended change, and is not bound to present changes brought to it by members.
- 4- Shall meet periodically, at the request of the Moderator or Director of Missions, to review the various procedures and practices of the association, and make regular reports to the Executive Board.
- 5- Shall give advance notice which is as far reaching and wide ranging as possible of any/all constitutional changes which are recommended. However, recommended revisions which are presented to the Executive Board no later than its September meeting shall be construed as “advance notice” which is to be given to the Annual Meeting of the association. by this Committee.

## **Article VIII – DUTIES OF CHURCHES**

**SECTION A.** Churches represented in this association shall report to the association by completing the (ACP) Annual Church Profile and making every effort to meet the requested date.

**SECTION B.** It shall be the duty of each church represented in the association to pay a reasonable part in supporting the ministries of the association.

## **Article IX – THE EXECUTIVE BOARD**

The Executive Board shall be composed of all elected officers of the association plus two (2) messengers from each cooperating church that is in fellowship with the association (as well as the Pastor of those cooperating churches, who shall have voting privileges as ex-officio representatives of their respective churches). All messengers from the churches shall be elected by the church of which they are members. They shall be elected to serve for one (1) year, and their names shall be reported to the association on the (ACP) Annual Church Profile. Changes in the names of messengers from the churches can be made by official church action and notification to the Executive Board, subject to the criteria given above.

The Executive Board shall be subject to the orders of the association; and none of its acts shall conflict with action taken by the association in either its Annual Meeting or Special Meetings.

The presence of elected Executive Board members shall constitute a quorum in conducting business. Regular meetings shall be held at a time, place, and date set by the Executive Board.

The Executive Board shall have the responsibility of the work of the association between Annual Sessions. The minutes of each meeting shall be presented to the association in each Annual Meeting.

The Executive Board shall not usurp the authority given by the Constitution or the association in session to any Committee, program body of personnel, including the DOM.

## **Article X – AMENDMENTS**

This Constitution may not be amended at any time until the amendment is read at an Executive Board meeting prior to the Annual Meeting, with the vote being taken in the Annual Meeting. A two-thirds (2/3) majority vote of those present and voting is required to adopt any/all changes to this Constitution.

## Rebuild Ministry Team Report 2020-2021

The Rebuild Ministry (formerly Mission Development) was adopted in 2001 as a BEBA home mission project. At the start of this year, we had 07 ramp requests from the past year and we received an additional 24 requests for a total of 31 requests. There were 22 handicap ramps with 15 handicap ramps remaining. The totals are 16/31 or 51.0 % completion (note: we only attempt to do 2 jobs a month which would give us a total of 24 Jobs a year. Therefore actual ratio for the year would be 16/24 for a 66.0% completion for the year, due to COVID we didn't work for 2 months). At the year's end, there are 13 projects that are on the list and are in need of our attention. The 07 requests that were refused were because: no longer in need (1), Couldn't contact (1), Owner permission (1), others or family completed the job (1), Decided The request wasn't necessary (3).

# Ministries of Executive Board 2020 - 2021

## Baptist & Reflector

*The Baptist and Reflector continues produce and share articles and columns that impact Tennessee Baptist Convention churches. Like the rest of our Tennessee Baptist family, the paper is continuing to minister effectively as our nation still recovers from and continues to deal with COVID-19.*

*The B&R is mailed to more than 17,400 homes 26 weeks a year, reaching nearly 44,000 readers. Last year, we celebrated our 185<sup>th</sup> anniversary and we are excited that we can continue to tell the story of Tennessee Baptists. Earlier this year, the B&R staff was recognized for excellence in journalism by the Baptist Communicators Association in its annual awards competition. The B&R was selected as the second best Baptist paper in the nation in terms of both design and content.*

*In addition, the B&R website has grown steadily since it was introduced in late 2015. We continue to experience tremendous growth with our website. Our number of page views continues to grow. We also send out a weekly newsletter highlighting top stories in the print issue but other articles that are posted on the website but may not appear in the print issue.*

The goal of the paper is to “tell the story of Tennessee Baptists” through news, feature stories and photographs. As in the past, the paper this year placed a major emphasis on what Tennessee Baptists are doing to reach the world for Christ by focusing on stories related to missions and evangelism. This year the paper has focused on timely topics as churches return to what they were doing before COVID-19 impacted the world in 2020.

*The Baptist and Reflector continued to utilize social media tools in 2020 such as Twitter and Facebook. Editor Lonnie Wilkey regularly writes a blog that provides information for Tennessee Baptists between print issues.*

The staff monitors trends that could affect Tennessee Baptists and prints those stories to keep readers informed. In addition, opinions, both from the editor and others, are printed and are intended to make readers think, reflect, and act.

The paper continually seeks to enlist new subscribers. The Church Trial Plan is still available for churches that want to introduce the paper to its members. We need more churches willing to send the paper to their leadership such as deacons, Sunday School teachers, etc. We are asking every reader of the *B&R* for the next year to consider sending one subscription to someone they know. *If just a small percentage of our readers would do this, our print circulation would significantly increase. **Baptist Memorial Health Care System**  
**Memphis, Tennessee**  
**Jason Little, President and CEO**

Baptist Memorial Health Care began as a 150-bed hospital in downtown Memphis in 1912. It was formed by the Southern Baptist Conventions of Tennessee, Mississippi and Arkansas because they recognized a tremendous need for a health care facility in this part of the country. The hospital's early days were rough – at one point, it almost closed – but eventually it grew to become the largest private hospital in the world. The hospital played a very important role in the history of health care in the 20th century, celebrating many firsts along the way.

The Baptist Memorial Health Care system was created in 1981 to provide an integrated health care delivery system offering a full continuum of care to communities throughout the Mid-South. Today, a total of 22 hospitals in Arkansas, Tennessee and Mississippi; an 800-member physician group; and dozens of other entities are affiliated with Baptist.

Baptist Memorial Health Care's staff chaplains are a part of the health care team. Patients, family members or employees know that they can ask for a chaplain at any time to augment our health care with spiritual or emotional care. In our hospitals, our chaplains represent their own faith but often deal with spiritual issues that transcend denominational lines.

Because of the COVID pandemic, we had to pause the Rev. Jimmy Terry Preaching Series events – where each month, a speaker delivers an evangelical message at our flagship hospital –but we resumed it in July 2020 with limited in-person seating and an emphasis on virtual attendance. Since the beginning of this year, we've been gradually moving toward having more in-person attendance. Thousands of people virtually attended the sermons, and videos of the messages have been viewed 86,800 times on Facebook.

Baptist continued to be the Memphis area's source of truth and accuracy about COVID-19. To date, we have earned 74% of the COVID-19 news coverage, and Baptist's experts were interviewed for almost 1,000 print and TV news stories on national and local news outlets.

We are planning to break ground on our first freestanding emergency department (FSED) in September. Located in Arlington, Tennessee, a Memphis suburb, it will serve a four-county area that includes two communities that lost hospitals and don't have convenient access to emergency care. Today, many patients in these areas travel up to an hour to come to Baptist Memphis. The new FSED would cut that commute in half. The FSED will have eight rooms, a CT scan, X-ray, ultrasound imaging and a helipad. We'll also bring more than 30 high-wage, professional positions to the community.

# Associational Report 2021

## Carson-Newman University

Your partnership and support enable us as Christian educators to help our students reach their full potential as educated citizens and worldwide servant-leaders.

This past year has included:

- Carson-Newman's Board of Trustees approved a five-year strategic plan entitled "Acorns to Oaks: Pursuing God's Preferred Future." The strategy calls for new academic buildings, expanded athletic offerings, new and renovated facilities, enrollment growth and greater missional alignment. The plan culminates in 2026, which marks the 175<sup>th</sup> anniversary of C-N's founding.
- In July 2021, Carson-Newman launched the first project from the new strategic plan: breaking ground on the Drama and Ted Russell Center. The new 48,000 square-foot health sciences building will be home to C-N's Nursing Department. The three-story building is slated for completion in 2023.
- At the opening of the 2020-21 academic year, the University announced a record enrollment of 2,911 students. This marked two years in a row C-N celebrated an enrollment record. It also welcomed a record number of graduate students (1,189). The school later celebrated a record spring enrollment of 2,729.
- The University was featured by U.S. News & World Report, which ranked C-N in the top 10 in the state overall and second in Tennessee for social mobility. It also named C-N's online graduate education program No.1 in the state. The University was touted as the state's highest-ranked private school in the "Best Online MBA Program" category.
- In recognition of a lifetime of service by alumni and missionaries Dr. Bill and Linda Viel, C-N named its campus ministries building in their honor and renewed its focus on Gospel sharing and Gospel living.
- In the fall, the University hosted the Gospel Saturated Life Conference featuring Dr. Wade Akins of Pioneer Missions Global as its speaker. Students heard the power of missions from Akins who has served as an evangelist, missionary and trainer of church planters in 54 nations.
- Relying on creative ways to carry out its annual Operation Inasmuch day of service during COVID-19, students learned how to use and leverage online personal platforms to benefit and advocate for such organizations as Habitat for Humanity, the Emerald Youth Foundation and C-N's community ministry, Appalachian Outreach.
- The University announced Dr. Jonathan Akin as its new vice president for Church Relations and Campus Ministries. Akin previously served as director of Leadership Development for the NAMB. Akin also serves as associate professor of religion.
- C-N named Jeremiah Young as its new director of Campus Ministries. Young previously served as student pastor at Manley Baptist Church in Morristown.
- The University welcomed Drs. Andrew Burrow and Marshall King as assistant professors of religion.
- Carson-Newman hosted IMB President Paul Chitwood as its Spring Commencement speaker.

Harrison-Chilhowee Baptist Academy celebrates 142 years as a distinctively Christian school, serving East Tennessee and the World. For the past 28 years, Tennessee Baptist's accredited Christian boarding and day school has operated as The King's Academy. International students are the academy's most distinctive feature—over 1,050 students from 99 nations have enrolled since 1935; an average of 14 countries are represented in the academy student body each year.

The academy remains focused on its VISION – *Transformed Lives, Empowered by Christ-like Character, Pursuing Academic Excellence and Lifelong Service – and committed to its MISSION: The King's Academy inspires and equips students of all cultural backgrounds to fulfill their God-given potential in a nurturing, college preparatory community.*

The academy continues to face challenges on the heels of the global pandemic, with the majority of operations shifting back to a new sense of normalcy and a return to on-campus learning and activities. Enrollment for the upcoming school year (2021-22) has eclipsed the previous year's numbers, and projections place the student body near the enrollment levels prior to the Covid-19 pandemic. Moving forward, the academy must balance the socio-economic demographics of academy families to remain financially feasible for both local and international students in order to remain a viable partner for faith-based education.

TKA welcomed Jeremy Sandefur as the new President/Headmaster for the 2021-2022 school year and is excitedly looking to the future. While the heritage of TKA is rich and deep, the days ahead are bright as the new administration focuses on developing servant leaders who will change the world for Christ. Through focusing on service leadership, TKA desires to reach the surrounding communities while providing a biblically based approach to curriculum and service instruction.

The newly formed "Love Where We Live" initiative will place TKA students in strategic partnerships throughout the communities of East Tennessee in order to serve and to learn more about the Lord through service. Day and Boarding students will participate in grade level mission projects to develop a deeper understanding of God's creation and to inspire a culture of service. TKA will seek to continue to be the choice for a Christ-centered, academically challenging education while fulfilling the Great Commandment of making disciples of all nations.

It is a distinct privilege for the academy family to partner with and serve alongside Tennessee Baptists in the mission of Christian education.

## Tennessee Baptist Adult Homes, Inc. Report to Associations, 2021

Though I wish that I could report to you that we did not experience any cases of Covid-19 in our homes, I cannot do that. I can, however, report that we had only a few infections and we have been successful in limiting any wider spread. That is because of the faithful men and women who serve as direct care providers in our six group homes. As always, I remain grateful and appreciative for their diligence and vigilance as they joyfully “*Show What Love Is.*”

We were able to get our residents vaccinated very early (January) due to them being a part of a priority group. Because we’ve been vaccinated, we are again able to conduct placement interviews. We are hopeful to fill our vacant group home beds over the coming months.

I mentioned in last year’s report that the proceeds from the sale of Williams Ferry Pointe in Lenoir City were going to be used to help us realize a **two-fold vision** to...

1. Establish a significant endowment that will produce operating income. Our Father’s Day Offering has never managed to rise to a level to offset our operating deficit.
2. Establish a small senior living community in Humboldt on land we already own where we can provide modest, comfortable retirement living (probably duplexes) for financially needy seniors, with priority given to indigent pastors and missionaries. TBAH will own these facilities and rent them on a sliding scale basis. They will be for independent living seniors; we will provide no health care or physical assistance. The Humboldt project will be a TBAH ministry in west Tennessee!!

Part 1 of our vision has been realized through the establishment of the SOAR fund (Supplying Ongoing Aid to Residents) through the Tennessee Baptist Foundation. The SOAR fund is now growing interest that will be used to help offset our operating deficits. Part 2 of the vision will have broken ground and at least one duplex unit will be nearly complete by the time of the 2021 Summit!

Finally, I am sad to report that we had to cancel Special Friends Camp for the second year in a row due to our inability to find vaccinated Counselors. We were able to provide an online “virtual camp” experience with live ZOOM sessions and pre-recorded videos and activities during the week that would have been SFC at Camp Linden. We have every intention of returning to SFC in 2022 and will be using this year to make some major changes to the format and organization of camp so that we will come back fresh and improved.

## Tennessee Baptist Children's Homes

2021 marks the 130<sup>th</sup> year that Tennessee Baptist Children's Homes has been welcoming children in hard places with the love of Christ. We are only able to welcome these children into our homes because of the faithfulness of churches, businesses and individuals who have a heart for children and families who are struggling. Thank you for your prayers, for your service and for sharing your financial resources with TBCH. We are committed as a ministry to operate without the use of government funds relying on God's people to supply the resources necessary to meet the needs of the children and families we serve.

The Lord has once again shown His faithfulness to this ministry by providing the necessary resources for us to care for 220 children during the first nine months of our fiscal year. **Five** of these children have been born again! Rest assured that TBCH is Christ centered in our approach to dealing with children and their families. We believe Jesus is the ultimate answer to all brokenness and our team unashamedly points people to Him in age-appropriate ways.

TBCH has provided **Residential Care** for 77 children since November 1, 2020, in our on-campus homes. Fourteen of these children have been successfully reunited with their families. TBCH is also committed to assisting those who age out of our program. These 18+ year-old **Independent Living** residents on our Chattanooga Campus receive continued support by our staff and learn a trade or attend college. We are committed to helping these young people get off to a good start in early adulthood. There are presently seven young people in our Independent Living program.

TBCH's **George Shinn Foster Care** program has served 143 children since November 2020 and has 74 foster homes on our team. Twenty-five children have been adopted into Christian families while 12 children are presently in foster-to-adopt situations!

Our foster home in **Oakdale** and our most recent newly opened home in **Kingsport** have the capacity to welcome large sibling groups of foster children. These two homes are both manned by families who sense a calling to care for vulnerable children and I am thankful for their willingness to help us serve children. TBCH is grateful for the churches and volunteers who are helping these ministry locations thrive!

TBCH's **Family Care** program stands ready to provide training for your church in child abuse awareness and prevention. ***Stewards of Children** is a sexual abuse awareness training provided by Darkness to Light which is a non-profit committed to empowering adults to prevent child sexual abuse. This is a two-hour video-based curriculum containing the heroic stories of sexual abuse survivors. These testimonies are coupled with professionals and counselors who provide guidance for individuals and churches when it comes to raising awareness and preventing abuse in your church and community. TBCH has six staff members certified to lead **Stewards** in your church or virtually! Ninety-one individuals have been trained in **Stewards** this year. ### **2021 Annual Report to Associations**

Since 1938 the Tennessee Baptist Foundation has been of service to Tennessee Baptists and Kingdom causes around the world. The assets under management of the Foundation have grown from \$6,577 to \$179 million during that time. God continues to bless this ministry and we are pleased to make our report to the associations as to highlights for the fiscal year 2020-21 thus far. The Foundation is pleased to offer the following services to Tennessee Baptists:

- **Presenting informational Faith-based estate planning seminars for churches**
- **Working with individuals, helping them develop distinctively Christian personal estate plans**
- **Assisting individuals in their establishment of various Charitable Trusts**
- **Serving as Trustee of trusts and funds committed to its care**
- **Providing investment services to Tennessee Baptist churches, associations and institutions**
- **Helping churches establish Legacy Ministries**
- **Facilitating loans to Tennessee Baptist churches/associations**
- **Providing grants for qualifying new ministries and projects**

Highlights of the Foundation's stewardship thus far for this fiscal year include:

**Funds under management: Over 1,100**

- **Assets under management: \$178,965,513 (as of June 30, 2021)**
- **New fund additions as of June 30, 2021: \$998,838 (12 new funds)**
- **Educational scholarships: 164 - totaling \$175,100 for 2021-2022 academic year. (Awarded over \$5.8 million in scholarships since 1987)**

## Tennessee Woman's Missionary Union 2021 Annual Report

In 2020-21, Tennessee WMU challenged Tennessee Baptists to be relentless in living authentic faith in Christ, seeking God in prayer, giving sacrificially, and witnessing to others. This report shares information about some of the state events, ministries, and initiatives that have taken place.

Due to staff transitions and the pandemic, many events were cancelled, some shifted to an online version, and new opportunities were developed

A BEST OF JAM Kit was compiled with some of the favorite JAM activities and lessons from past years and was made available for churches, groups, or families to use with their children.

Virtual Get-Together & Connection was held online on March 20, 2021, with content being available to registrants to view on demand through June 30, 2021. Of the 559 people who registered, at least 444 viewed the online content and they represent over 175 churches. Tennessee Baptist Children's Home received this year's ministry project gifts through an Amazon Wishlist.

As part of Tennessee WMU's Denver prayer advocacy partnership, Virtual Denver Prayer Tours were held from October 2020-August 2021. Each virtual session introduced church planters and allowed participants to pray for them and their families.

Holding the Ropes: Devotions and Praying for Missionaries video series was shown on the Tennessee WMU Facebook pages and groups in late 2020. These daily devotions and prayer times for missionaries were led by older missions-minded youth, young women involved in WMU and missions, WMU Scholarship recipients, and IMB missionaries from Tennessee.

3 Circles Evangelism training video with supporting materials targeted for youth groups was produced and distributed.

Zoom with a Missionary online meetings were hosted allowing missionaries to interact with children/youth missions discipleship groups. There were children's groups from 25 churches who met missionaries from North Africa, Philippines, Italy, Thailand, Spain, Japan, China, North Africa, Venezuela, and from the United States – Colorado, Louisiana, and Ohio.

Tennessee WMU joined Sisters Who Care Chattanooga as they hosted a multi-state/regional meeting via Zoom on March 26-28 with over 80 in attendance. Sisters Who Care is the African American expression of Women on Mission.

Covid restrictions opened up for Tennessee WMU to be able to host a very scaled back Annual Meeting on May 1, 2021, at First Baptist Church, Cookeville. ## **Tennessee Woman's Missionary Union** **2021 Annual Report** Cont.

- Checks for \$150 were sent to 20 missionary kids whose parents serve with IMB and are from Tennessee.
- Checks for \$50 were sent to 94 retired IMB missionaries who were born in Tennessee.

These gifts are made possible through an allocation from the Golden Offering for Tennessee Missions for nurturing Tennessee missionaries and their families.

In April 2021, \$35,275 in scholarships were awarded to 34 students attending graduate school, seminary, as well as undergraduate schools in Tennessee during the 2021-22 school year. These scholarships are funded through endowments, invested funds, and the Golden Offering for Tennessee Missions.

Christian Women's Job Corps and Christian Men's Job Corps are ministries of WMU that seek to help men and women break the cycle of poverty through job and life skill classes, Bible study, and mentoring. Last year the 21 sites in Tennessee reported serving 425 participants.

Missionary Houses in Mt. Juliet – Mary's House (WMU House) and the Missions Mobilization Center (MMC) House continue to be a hub of activity as they provide a place for our missionaries to rest and reconnect with family and friends. The Worthy family arrived at Mary's House in June 2020 and have extended their stay through February 2022. After staying at the MMC Missions House for a year, Frank & Sheri Moran moved out on April 30, 2021. Jason & Jennifer Vanover moved into the MMC Missions House on May 20, 2021 and will be staying through January 31, 2022.

The theme for the 2020-21 Tennessee Missions Emphasis was "See and Tell Tennessee." The suggested dates for the Week of Prayer for State Missions were September 13-20, and the goal for the 2020-21 Golden Offering for Tennessee Missions was \$1,800,000. The total amount given as of July 27, 2021, was \$1,686,665. The offering year goes from September 1 – August 31.
